









Established in 2009 by King Hamad bin Isa Al Khalifa, the Isa Award seeks to honour the individuals and organisations around the globe that have served humanity in a profound way.

Named after the late Amir Shaikh Isa bin Salman Al Khalifa, this award celebrates his life-long dedication to humanitarianism and the distinctive impact he made on his country and the world.

The Isa Award is granted every two years to an individual or organisation selected by a committee of distinguished scholors, experts, and public figures. The laureate will be awarded a royal certificate of merit, a gold medal, and a prize of one million U.S. dollars.




projects was to address the housing shortage in the country as the population boomed over the century.

The Isa Award recognises the world changers amongst us whose tireless service through acts of compassion and innovation has helped in restoring faith in humanity and in producing a better world for succeeding generations.

MISSION

The Isa Award for Service to Humanity has been established with a three-fold goal, to create awareness of extraordinary humanitarian endeavours across the world, to inspire more people to achieve excellence in humanitarian accomplishments, and to honour individuals and organisations who have singularly demonstrated an ability to make a positive impact in the world.

AWARD CATEGORIES

The Isa Award for Service to Humanity is awarded to exceptional individuals or organisations whose selfless actions produced long-term benefits to the general public, enhanced efforts in finding solutions to humanitarian and social problems and issues, and adopted creative ideas and theories to raise the standard of life.

The nominees are selected by a judging committee who examine their contribution to humanity in fields that include disaster prevention and relief, education, community service, dialogue among civilisations, human tolerance, international peace, urban development, environment and climate change, scientific innovation or poverty alleviation.

RULES OF ENTRY

- The nomination forms must be submitted in either English or Arabic.
- The applicant shall not be less than 18 years of age.
- Only those applications that comply with the official nomination criteria shall be approved.
- The award will cover areas that include disaster prevention and relief, education, community service, dialogue among civilisations, human tolerance, international peace, urban development, environment and climate change, scientific innovation or poverty alleviation.
- The humanitarian project objective must be clearly defined.
- The details of the quality and quantity of the targeted category must be clearly outlined.
- The form must include the precise humanitarian impact of the project and its underlying benefits to humanity.
- Facing the challenges for the service of humanity must be outlined.
- The Secretariat shall notify the candidates in writing that their applications have been received.

FIELD VISIT

The Board of Trustees will assign a group to undertake a field visit to the project site and conduct a personal interview with the potential applicant. The group will comprise members of the secretariat, advisers and other competent professionals with experience in diverse areas.

Taqi Mohammed Al Bahrna - Second Deputy Chairman

Currently the Second Deputy Chairman of the Board of Trustees of the Isa Award for Service to Humanity, Taqi Al Baharna's professional trajectory has spanned the financial and business worlds in addition to a notable political and literary career. As Bahrain's Ambassador to the Arab Republic of Egypt between 1971 and 1974, Al Baharna's endeavours were greatly esteemed by the Egyptian authorities. During the same period, he also represented Bahrain in the Arab League and was awarded a First Class Order of Merit by President Anwar Sadat in 1973. Between 1993 and 2002, he was a member of the Bahrain Shura Council and led its Committee for Foreign Relations. Moreover, Al Baharna has authored a wide body of work, ranging from literary to poetry.

Shaikh Khalid bin Ahmed bin Mohammed Al Khalifa -Board of Trustees Member

Bahrain's Minister of Foreign Affairs since 2005, Shaikh Khalid began his career in the very ministry he now leads before moving to the Office of the Deputy Prime Minister in 1995 where he worked as a Chief Liaison Officer responsible for the Maritime Delimitation and Territorial Dispute between Bahrain and Qatar. His contribution and role were so profound that he was awarded the Bahrain Second Class Medal by HM King Hamad bin Isa Al Khalifa in 2001. After a period in the Court of HRH Crown Prince, Shaikh Khalid was appointed Bahrain's Ambassador to the United Kingdom, Kingdom of the Netherland, and the Republic of Ireland. Shaikh Khalid is also a member of the Supreme Defence Council, the Economic Development Board and a number of Ministerial Committees.

Dr. Mohammed Ali bin Al Shaikh Mansoor Al Sitri -Board of Trustees Member

Professor AlSitri has always placed a great emphasis on Islamic law and education, having spent his life studying Islamic jurisprudence, engaging in local research and service to society. With a series of academic qualifications to his name, ranging from Arabic language to Islamic law and public administration, Professor Al Sitri is an Advisor to HM King Hamad bin Isa Al Khalifa for Legislative Affairs. A founding member of the Council of Islamic Parliaments and Chairman of the Board of Trustees of the Jaafari Awqaf(religious endowments), he has also held a number of ministerial portfolios acting as the Minister of Justice and the Minister of Municipalities at different times during his distinguished career.

Shaikha Mai bint Mohammed Al Khalifa -Board of Trustees Member

A leading figure in the Arab culture and art scenes, HE has spearheaded national efforts to develop the cultural infrastructure for heritage conservation and the growth of sustainable tourism. President of the Bahrain Authority for Culture and Antiquities, after holding the Ministry of Culture & Information and then the Ministry of Culture. As the founder of the Shaikh Ebrahim bin Mohammed Al Khalifa Center for Culture and Research, she launched the nation-wide "Invest in Culture" initiative, building an unprecedented partnership between the private and public sectors for heritage preservation. HE was honored by International institutions and received the highest decorations from France, Italy, Morocco, Bahrain among others.

BOARD OF TRUSTEES

Shaikh Mohammed bin Mubarak Al Khalifa - Chairman HH Shaikh Mohammed bin Mubarak Al Khalifa is a Deputy Prime Minister in the Kingdom of Bahrain. A public servant throughout his distinguished career, HH Shaikh Mohammed first served his country as a magistrate. He played an active role in the negotiations with the United Nations Fact-Finding Mission which led to the independence of Bahrain. He was the country's Minister of Foreign Affairs and a member of the Supreme Defence Council. One of the highlights of his career was his active involvement in the resolution of the boundary and maritime disputes between Bahrain and Qatar.

Shaikh Khalid bin Abdulla Al Khalifa -First Deputy Chairman

Shaikh Khalid bin Abdulla Al Khalifa, a Deputy Prime Minister since 2010, began his long and illustrious career as a Roads Engineer in 1966, progressing slowly through the ranks within the Directorate of Works in Bahrain. He served as Minister of Housing for twenty years between 1975 and 1995, then Minister of Housing, Municipalities and Environment between 1995 and 2001 and finally, Minister of Housing and Agriculture until 2002. Moreover, he established Bahrain's Housing Bank and acted as the Chairman of the Board of Directors between 1979 and 2002. Amongst his many achievements in the field was the development and construction of Hamad Town, a government housing facility.

NATURE AND OBJECTIVES OF THE PROJECT

- The project will have to be purely humanitarian in its scope, and its nature and objectives should be explained in clear details.
- The project will neither be political in nature nor be affiliated to any political party.
- The beneficiaries of the project will not be limited to any one country but expanded to include a broader geographical territory.
- The award applicant shall not receive financial support from any governmental authority but shall rely on the contributions from individuals and institutions.
- The application form must include the number of individuals linked with the project – employees, associates, board members and other stakeholders
- The application form must provide a detailed overview of the community's relationship with the project.
- The form must include details about relations with other international organisations that are connected to the project.
- The form must provide full details about any other local, regional or international awards that the project has received or has been nominated.
- The form must provide information on how the project would be managed in the absence of the candidate for the award.

In applying the nomination criteria to the candidates, they would be grouped as individuals and institutions. The criteria applicable to each of the candidates shall be sorted accurately by correctly sorting, comparing the level of service performance, its varied dimensions, project output, its spread, diversity and humanitarian value. There will be a brief assessment of the award candidates that would include examining the performance of the individuals, relief centers and services projects, provided that there will be further research, audit and evaluation of the final short-listed candidates.

The Jury Committee will review the short-listed candidates and their requests, provide substantive merits on the differentiation between each of the candidates, explore the circumstances surrounding the selection process, and submit recommendations to the Secretariat and the Board of Trustees with their final decision.

After the study and evaluation of each individual candidate, the Committee shall come to a second assessment that would include three names. These names will be displayed with a distinctive sign of the candidate's work, the Jury Committee will then complete its work and present its results to the Board of Trustees.

Scientific Innovation

Dr. Mansoor Mohammed Sarhan -Board of Trustees Member

An established historian and academic, Dr. Sarhan has been the Director of the National Library since 2007, having served as the Director of Public Libraries between 1989 and 2006. An author of over 39 different works, Dr. Sarhan has written a number of biographies and cultural histories of Bahrain as well as translating foreign works for the Arab reader. He is a member of the Board of Trustees of both the Isa Cultural Centre, and the University of Bahrain. His interest in education has led him to serve on the Advisory Board of a private establishment - Al Naseem School. Currently he is a member of the Shura Council.

Ali Abdulla Khalifa - Board of Trustees Member -Secretary General of the Award

A writer, poet, researcher and cultural enthusiast, Ali Abdulla Khalifa has been the Director of Cultural Research at the Royal Court since 2001 and the Assistant Secretary General of the International Organisation of Folk Art (IOV) regional office since 2007. Amongst his many published works are 'Gulf of Songs,' 'Folklore Inspiration in Creative Works' and 'Folk Arts – Nations in Unison' in addition to a diverse array of poetry collections and operettas.

His work has earned him wide repute, winning him a number of international awards including the Cultural Competence Medal by the late President Bourguiba of Tunisia in 1973, the International Grand Prize for Arts in 2006 Romania and the Competency First Class Medal of HM King Hamad bin Isa Al Khalifa.

GENERAL SECRETARIAT

The General Secretariat is responsible for overseeing the operations of the Isa Award for Service to Humanity Nomination process and serving as a centralised coordination hub between the Board of Trustees and the Judging committee.

- ألا يكون المترشح قد حصل على أي دعم مادي من جهات حكومية وإنما اعتمد على تبرعات الأشخاص والمؤسسات.
- أن يحتوي طلب الترشيح على عدد العاملين أو المنتسبين للمشروع، أو مجلس إدارة المشروع.
- أن يتضمن طلب الترشيح شرحاً حول طبيعة علاقة المجتمع بالمشروع.
- أن يتضمن طلب الترشيح علاقة المشروع بالمنظمات الدولية وبخاصة ذات البعد الإنساني.
 - أن يشمل الطلب الجوائز التي حصل عليها المشروع أو رشح لنيلها.
- أن يشمل الطلب شرح الوضع الذي سيؤول إليه المشروع بعد غياب المترشح.

وبتطبيق المعايير المعتمدة على مجموعة المترشحين أفرادا ومؤسسات من مختلف أنحاء العالم، تتولى لجنة التحكيم فرز من تنطبق عليهم المعايير الدقيقة كمرشحين محتملين، وبالمزيد من التدقيق على ما تم فرزه والمفاضلة بينه فيما يخص مستوى أداء الخدمة الإنسانية وأبعادها ومخرجات مشاريعها وسعة انتشار وفاعلية تأثيرها وتنوع هذا التأثير وقيمته الإنسانية، يتم التوصل إلى كشف مختصر أولي للمرشحين لنيل الجائزة ويُجرى في الجلسة التالية المزيد من البحث والتدقيق والتقييم للتوصل إلى القائمة المختصرة بصورتها النهائية.
